# Minutes of the COUNCIL MEETING held on 13 October 2014 at 7.00 pm at the Parish Council Office, 7 Hampton Drive, Cronton.

# 65. APOLOGIES

All Councillors were present.

# 66. DECLARATIONS OF INTEREST

It was reported that no declarations of Interest were received.

#### 67. <u>MINUTES</u>

**It was resolved** to accept the minutes of the Council Meeting held on 2 September 2014 as an accurate record and signed by the Chairman.

# 68. <u>CO-OPTION</u>

It was proposed by Councillor D Rostance, seconded by Councillor Shaun Cooper and unanimously **RESOLVED** that John Foran be co-opted member of the Parish Council with immediate effect.

The Chairman welcomed Councillor John Foran to the Meeting.

#### 69. KNOWSLEY COUNCIL – LOCAL PLAN

Lisa Harris and Justin Wilson of Knowsley Council had been invited to give an update on progress in preparing the Knowsley Local Plan: Core Strategy (the 'Plan') and to discuss proposed changes to the Plan.

The Government Inspector has accepted a vast majority of the Plan but has also identified some critical issues where changes are needed. These include a shortfall in the 5 year deliverable land supply for housing development up to March 2018 that requires earlier release of land from the Green Belt, and a need for early release of land from the Green Belt to provide land for a new business park and large scale distribution uses. Major sites close to Cronton are 'South of Whiston' and 'Land South of M62' (including Cronton Colliery). Extensive consultations are being carried out.

Issues raised:

- Is it Government's strategy to release green belt?
- The motive of early release of land from the Green Belt.
- How will Cronton be affected by all these developments?
- Traffic impact on A5080 main road to Cronton.
- School places and provision of necessary infrastructure.

Response:

- The Inspector has endorsed the proposed modifications.
- The proposal has received Knowsley Council's support.
- Limited brown field supplies.
- The proposed developments are sustainable
- Possible impact is controllable.
- Comprehensive plans for the sites are being looked at, which are subject to further public consultations.
- Developments will have to go through planning application procedures.
- Written consultation notification have been sent residents within 200 meters of the 'South of Whiston' and 'Land South of M62' sites

The Chairman thanked the Knowsley Officers for the information and for attending the meeting.

**It was resolved** that (i) the briefing on Knowsley Local Plan: Core Strategy – Consultation update be noted, (ii) the consultation be further discussed at the General Purposes and Environment Committee to be held on the 27 October 2014. The outcome of discussion will be publicised. (iii) Information on the proposed Sustainable Urban Extensions (South of Whiston and Land South of M62) will be displayed with the consultation notice in the office window.

All hedges along the edge of the fields on the south side of Cronton Road from Sandy Lane to the roundabout outside Cronton Nursery had been removed. It was suggested contacting Knowsley Council to investigate the matter.

It was reported that Sandy Lane had been cleansed by a large mechanical road sweeper.

- The proposal is totally against Knowsley Council's current planning policies (UDP adopted in June 2006 and Green Belt Policy).
- The proposed development is in the green belt.
- It involves demolition of existing buildings.
- The proposed development is a complete change in the use of land.
- It is a major housing development.
- It will completely change the appearance and character of the rural landscape and the environmental quality of the area.

- (b) Hack Back CIC\_- It is a community organization based in Cronton. A combination of psychological therapies with interaction with Birds of Prey is used to address a wide range of issues. They are considering running a series of workshops free of charge to service user in Cronton. The workshops will be for a maximum of 10 people and will be for 2 hours per week for 6 weeks.

**It was resolved** that approval be given to Hack Back CIC to use the office premises for the proposed workshops free of charge subject to receiving a copy of insurance.

Councillor S Cooper will contact the workshops organizer for clarification regarding the birds and suitability of the premises for such workshops.

#### 79. STATE OF THE VILLAGE

- (a) Send a thank you letter to Knowsley Council for the jobs that have accomplished.

- (a) A group of 5 teenagers from Widnes is causing concern.
- (b) Noise from a group of people congregated on the Pasture up to the early hours of the morning is causing nuisance to neighbours. It was suggested seeking assistance from Philip Hurst of Knowsley Council to put a notice up that the Pasture is a Day Light Park. The Chairman undertook to follow the matter up with Philip Hurst.
