### 25. CRONTON NEIGHBOURHOOD NETWORK

Neighbourhood Network was set up as part of the structure of Knowsley Council's Partnership Board in 2007. The Parish Council agreed to facilitate the meetings from 2011. Councillor G McGann is concerned about the role of the Neighbourhood Network. He commented that the Police and Ward Councillors attend the Network meetings but not the Council's. As the Council officially represents the interest of the electors and residents should raise their concerns with Council members in the first instance. To avoid further confusion and duplication, he felt that the Network should be dissolved.

The Chairman responded that the Network is governed by its constitutions and the Council has no power to dissolve it. He further pointed out that consideration is being taken to widen its remit to ensure all sectors of the community are represented. Comparing with Council meetings, the Network is less formal and all members and representatives can participate in discussions. Parish Councillors are encouraged to liaise with individual community groups.

A discussion took place about Police and Ward Councillors representation at both settings.

**It was resolved** to check what support there still is for the Network from Knowsley Council and if the support for the Network still one of Knowsley Council's priorities. The Police and Ward Councillors are to be invited to attend the Council meetings.

#### **26. SCRAMBLER BIKE ISSUE**

Scrambler bike issue is a national problem. Police is aware of the issue in Cronton and is patrolling the area. Residents should report incidents to the Police.

# 27. STATE OF THE VILLAGE

The followings had been discussed:

- (a) Pavements in Wheatfield Road have not been resurfaced.
- (b) Pavement repairs in Lambourn Avenue have to be carried out.
- (c) Parking bays outside the shops on Hampton Drive needs resurfacing.
- (d) Extra security lights at the Cronton C of E Primary School have caused concern in the neighbourhood.
- (e) A progress update on the boundary signs.

# 28. ANTI-SOCIAL BEHAVIOUR

An incident of over 100 young people gathered in the village on a Friday evening in April has caused serious concern. Trees and an item of play equipment had been vandalised. It has been reported to the Police. To raise awareness, the incident will be reported in the next newsletter.
