# **COUNCIL MEETING**



# Minutes of the COUNCIL MEETING held on 30 March 2015 at 7.00 pm at the Parish Council Office, 7 Hampton Drive, Cronton.

# 153. APOLOGIES

It was resolved that apologies for absence received from Councillor I Watson be accepted.

# 154. DECLARATIONS OF INTEREST

It was reported that no declarations of Interest were received.

# 155. <u>MINUTES</u>

**It was resolved** to accept the minutes of the Council Meeting held on 16 February 2015 as an accurate record and signed by the Chairman.

# 156. PUBLIC PARTICIPATION

Inspection G Webster and Sergeant Paul Carroll were invited to discuss policing matters in Cronton. The following issues were raised by members of the public:

- (a) Private companies' responsibilities in respect of illegal parking It was responded that some policing services are to be delivered by private companies, however, responsibility for the enforcement of legislation governing dangerous parking and parking that has caused an obstruction remains with the Police.
- (b) A dangerous pothole in Hall Lane It was responded that it is an environmental issue.
- (c) Police response It was advised to use landline to report incidents for area identification. Police can be deployed from other areas if necessary.

The following environmental issues were raised:

- (a) A pump to be installed by United Utilities at Pex Hill It was suggested contacting United Utilities for further details whether it is a subterranean construction or above ground.
- (b) To improve the condition of the public footpath at Mill Lane leading to Pex Hill, the surface should be tarmacked.

# 158. POLICING

The following issues were considered:

- (a) Location of Cronton There is always some confusion in identifying the location of Cronton when an incident is reported to the Police or Fire and Rescue Service. It was suggested putting Cronton on the map that it is in Merseyside. Call handling procedures at the new control centre for Fire and Police services were briefly explained.
- (b) Anti-Social Behaviour III-behaved young people removed by Cheshire Police from Upton Rocks congregated on The Pasture throughout the night during last summer. Dave Rimmer attended the situation and successfully moved them out of the village. The community wants to be reassured that such incident would not happen again. It was responded that the Police takes anti-social behaviour seriously and residents should continue reporting incidents to the Police for action. Arrangements will be made for Police to attend incidents and to promote prevention.
- (c) Rural crimes A huge amount of lamping with firearms, and quad and scrambler bikes incidents. It was advised to call 999 to report potential firearm incidents. Two officers are trained to clampdown on quad and scrambler bikes crimes. Tackling rural crime is a priority for Police and they are working in co-operation with Cheshire Police.
- (d) Fly-tipping issues The village is a hot spot for fly-tipping. A person had been caught for fly-tipping in the village. The case has been passed to the Police for action.
- (e) Highways issues The 20 mph speed limit in Smithy Lane and Hall Lane is ignored by some drivers. HDVs travel to and from Hall Lane, north to the junction of Hall Lane/Penny Lane, but that stretch of road is not wide enough for two-way traffic. Some restrictions have to be implemented to resolve the situation. This will involve the Borough of St Helens. The Police can push this proposal forward to Knowsley Council.
- (f) General crimes It was advised to take precautions to prevent car crimes. A recent plant theft had been reported.

Dave Rimmer (ex-PCSTO) thanked for the co-operation of Parish Council and residents during his period of service in Cronton. Members were grateful for Dave Rimmer's service and dedication. He was a good ambassador in the area. They wish him all the best with his new job.

The Chairman thanked the Police Officers for attending the meeting and would appreciate their regular attendance.

# 159. <u>REPORTS</u>

- (c) **Bus service** Bus service 265 with a detour to Cronton will go out to tender. The new route starts from St Helen's Hospital via Cronton to Whiston Hospital and Halewood.
- (d) **Environment** The recent Clean-up Day was a great success. Fourteen volunteers took part in the event. The village is in a good condition.

(e) PWCKV Partnership Advisory Group – The focus of discussion at the second meeting was 'Get the best return from the Knowsley pound'. Representatives of the four areas put questions to the Advisory Group. A 'Strategic priority – Get the best return on the Knowsley pound' was formulated and agreed by the Knowsley Implementation Group. The priority list was presented to members. It includes the priorities of the Health and Wellbeing Board.
