#### 6. APOLOGIES

## 10. CLERK'S TERMS AND CONDITIONS OF APPOINTMENT

A report to assist members in deciding the Clerk's final pay (2014/15) for acknowledging her attainment of the Certificate in Local Council Administration (CiLCA) qualification was presented to the Committee for consideration and approval.

**It was resolved** that the Clerk's revised total salary for 2014/15 is £8,507.20. The pay rise of £201.47 will come from the General Reserve budget.

**It was resolved** that further information for clarification is needed. The Chairman and Councillor P M Green will look into it.
