# GENERAL PURPOSES & ENVIRONMENT COMMITTEE

Minutes of the meeting of the **General Purposes and Environment Committee** held on **23 January 2017** at the Parish Council Office, 7 Hampton Drive, Cronton, commencing at 7.00 pm.

## 59. APOLOGIES

It was resolved that apologies for absence received from Councillors P M Green and G Pentin be accepted.

## 60. DECLARATIONS OF INTEREST

**It was resolved** that a declaration of interest be received from Councillor W Cook in planning application (17/00016/TCA) for remedial pruning to 5 no. sycamore trees at 1 Brook Close as he lives in the same Close.

There were no other declarations.

### 61. MINUTES OF LAST MEETINGS

**It was resolved** to accept the minutes of the General Purposes and Environment Committee meeting held on 12 December 2016 as a correct record and signed by the Chairman.

#### 62. PUBLIC PARTICIPATION

There were no issues raised by the member of the public.

### 63. POLICING

The new Inspector Jane Moreau explained that Merseyside Police is undergoing reorganisation mainly due to funding cuts. There will be one centrally-based team and officers can be deployed to the most needed areas. PCSOs and officers will remain on the beat. The duty Officer can be contacted via a dedicated e-mail address.

Stg Peter Sprung presented a Crime Report for Cronton 2016 and went over some specific issues. A discussion took place as to how closer liaison between the Parish Council and the Police can be secured in view of the reorganisation. Provision of crime figures and policing information on a regular basis was suggested. Police newsletter co-ordinated by the Safer Community Team can be used as a liaison forum. Local community hub was also considered. Regarding PCSOs, besides policing their respective areas, they are also deployed to attend incidents. Their visibility may have decreased as they now have access to Police cars.

Cronton has a low crime rate, the effort of Police in achieving this is most appreciated. The Council hope this relationship will continue into the future.

The Chairman thanked the Police Officers for attending the meeting.

## 64. DRAFT HALSNEAD MASTERPLAN SUPPLEMENTRY PLANNING DOCUMENT (SPD) CONSULTATION

Lisa Harris (Director of Regeneration and Housing) and Rachel Apter (Planning Policy Manager) of Knowsley MBC gave a presentation on the draft Halsnead Masterplan. The followings were also highlighted and discussed:

- The Masterplan gives detailed guidance for developments.
- North of M62 is mainly for residential development.
- South of M62 is mainly for commercial development and a country park.
- 25% of 1,600 new houses is affordable housing.
- A new school will be built in the area.
- Consultants to undertake traffic impact assessment.
- No access to the site from Fox's Bank Lane.
- The cycle path from Whiston to the country park through to Cronton via Penny Lane is suggested.
- Provision of primary and secondary education for new residents.

The closing date for the consultation is 23 February 2017. The Plan will be adopted in April 2017. The Chairman thanked for the presentation.

### 65. TOWN END, CRONTON CONSERVATION AREA CONSULTATION

A drop in session took place at the Parish Council Office on 19 January 2017. The draft revised Town End, Cronton Conservation Area Appraisal and the draft Town End, Cronton Conservation Area Management Plan had been considered.

**It was resolved** that the proposed amendments to the boundary of the conservation area and the Management Plan be supported.

#### 67. VILLAGE ISSUES

The followings were discussed:

- (a) A birch tree at Coronation Gardens is overhanging the road (Smithy Lane) Knowsley Council to look into the matter.
- (b) There is a brook behind the fence at the back of the field of the Pasture. The gaps in the fence have to be looked at to avoid potential danger to park users and to prevent anti-social behaviour activities.
- (c) Parking issue at Iver Close Awaiting reply from Knowsley Council regarding the consultation.
- (d) Parking outside the shops on Hampton Drive A response from Knowsley Council regarding parking control was noted and not further action to be taken at this stage. Knowsley Council will be requested to reinstate the disabled parking space with more distinctive and easily recognisable marking.
- (e) Fly-tipping at the back of shops A 'No Fly-tipping' sign to be installed.
- (f) Dog fouling issue Raise awareness in the next newsletter.
