Pollution of Dog Clog Brook — CRONTON

Residents living near to the brook which passes through the village may have become aware of unpleasant odours. This is due to pollution as a result of illegal tipping of contaminated waste at the site of the old Rainhill sewage works.

Last year Knowsley Council asked the owner of the site to make it safe following concerns about safety and vandalism. It was agreed that clean, uncontaminated inert material could be used to cover the areas of the site deemed to be unsafe. Without the knowledge of the land owner contaminated waste was tipped at the site and then covered with clean material. Over time this has resulted in Leachate being released into redundant drainage systems, field ditches and drains that connect to Dog Clog Brook. The effect on the brook has been dramatic and pollution extends over 2 miles from the site.

Leachate is a solution that is formed by rain passing

through waste material. It does not pose a risk to health but in this case it has seriously affected the environment of the brook.

The land owner is cooperating fully with the relevant agencies to stop the flow of leachate. It is anticipated that the necessary work will be completed shortly. The Environment Agency assures us that the brook will recover over time particularly if exposed to heavy rainfall. There is likely to be some continuation of the public nuisance from odour, particularly during warmer weather and lower flows in the brook.

The Parish Council is liaising with a number of agencies to determine if more action can be taken to alleviate the problem. In the meantime we advise parents to warn children not to play near the brook.

The site is currently subject to a very complex criminal investigation. The land owner is spending considerable amounts of money to alleviate the problem and has offered a reward for information leading to a successful prosecution of those responsible.

PEX HILL LOWLAND HEATH

Neil McMahon - The Conservation Volunteers, Pex Hill



Pex Hill is one of Merseyside's last remaining areas of heathland contributing approximately 12% to Merseyside's lowland heath.

In Victorian times (1868) the first of the covered reservoirs was built by the Widnes Corporation on site, using sandstone mined from the quarry at Pex Hill. The water was used to feed the growing industry and population of Widnes. As this grew over time, two more reservoirs were added, the last in the 1930's.


In Edwardian times, Pex Hill was classified as common ground when local people used the site for grazing of domestic animals such as cattle and horses. These animals kept down any vegetation except for heather and other dwarf shrubs that were unpalatable to them.

Later in time, the site was occupied by 107 Anti-Aircraft Regiment and 443 Battery of the 61 Searchlight Regiment as it was ideal for spotting aircraft coming in to bomb Liverpool during in the Second World War.

United Utilities (North West Water at the time) acquired the site later and left it open to the public for recreational use. Unknown to many people of the area, the site is not actually a public park but private land that the land owner leaves open to the public.

In the past, it has been insufficiently managed and has lost much of the natural heritage that once inhabited the site. Projects that have been undertaken over this time have been extensive tree planting onto this important Biodiversity Action Plan (BAP) habitat as well as footpath construction and other conservation related projects.

Due to excessive nutrients increase and scrub and bracken invasion, the area over the past twenty years has declined as much of its natural flora and fauna has been lost, including grass snake and common lizard, last recorded around 1997.



What The Conservation Volunteers have been and are doing now!

What The Conservation (formally BTCV) has done over the past 7 years has been to introduce a management plan for the site. This includes reestablishing footpaths, introducing disabled friendly gates, woodland management and woodland planting to raise the biodiversity of the areas with the planting of approximately 850 mixed native species trees within the woodland and regime of heathland management to attempt restore the heathland back to much of its former glory. This has included the felling of some of the trees on the heathland area, mainly the more invasive birch, and the planting of approximately 1200 heather plants onto the heathland, not to mention the spreading of many different types of seeds to introduce other heathland species back to the site.

The Conservation Volunteers do understand concerns of local people who visit the site when they see trees being taken away from the heathland but would like to assure people that we only have the site's best interest at heart.
