It was responded that a large number of youths moved to the Pasture from Upton Rocks since restrictive orders were issued by the Cheshire Police in Widnes. Vandalism on the Pasture and lack of Police visibility in the community were concerns. It was suggested raising the issues with the Neighbourhood Inspector.
