Minutes of the Remote ANNUAL MEETING OF THE PARISH COUNCIL held on 7 SEPTEMBER 2020 at 7.31 pm at the Parish Council Office, 7 Hampton Drive, Cronton.

39. ELECTION OF CHAIRMAN 2020/21

It was moved by Councillor G McGann, seconded by Councillor D Bray and resolved unanimously that Councillor Shaun Cooper be elected Chairman for 2020/21.

40. CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE

After signing the Declaration of Acceptance of Office, Councillor S Cooper took the Chair.

The Chairman thanked Councillor Will Cook for his leadership and contributions to the Council and community during his time as Chairman, especially his work on the Pasture bringing it to a Green Flag status park. The Chairman looked forward to working with all members for the remainder of the 2020/21 civic year.

41. ELECTION OF VICE-CHAIRMAN 2020/21

It was moved by Councillor D Thomas, seconded by Councillor G McGann and

resolved unanimously that Councillor D Rostance be elected Vice-Chairman for 2020/21.

(a) Verge and bank of the field opposite Cronton Garden Centre – A written request had been received from Mr John Powell of Birchfield Community Association seeking support for the area be planted as a small meadow flower area when the site was cleared and restored.

The following questions were raised:

- The ownership of the site
- Maintenance of the site without the knowledge of Knowsley Council

The Ward Councillors and the Parish Council supported the proposal subject to resolving the questions raised. Councillor Ron Gaffney would liaise with Mr John Powell.

- (b) Fencing at the back of The Pasture Filling the gap in the fence was in progress and Councillor D Rostance would follow this up.
- (c) Climbing frame on The Pasture The smoke damaged climbing frame was structurally sound and a Knowsley Council Officer would repaint it in the near future.
- (d) Entrance gates at The Pasture The damaged gates were tied together as a temporary measure. Knowsley Council had been informed to repair them.
- (e) Fencing at Pex Hill The damage had been reported to United Utilities. Councillor D Rostance would follow this up.
- (f) Communication with Police Lack of response from Joanne Matthews, Safer Communities Area Officer. It was advised to keep trying.

Halsnead Garden Village development – Councillor T Byron would provide feedback.

Councillor R Gaffney reported on the following:

- Parking near road junction Could seek assistance from Knowsley Council Civil Enforcement Officers.
- Smiley face speed indicator device A new device would be assigned to Cronton.
- **Footpath overgrowth** Had a site meeting with a Knowsley Officer Paul Christopher. Overgrowth would be cut back on Sandy Lane and the footpath by Cronton Hall.

Footpath between Penny Lane and Fox's Bank Lane – A 'Private - no admission' sign was erected by a gate. Knowsley Council's Definitive Rights of Way Map (2006 Draft) included this footpath. Councillor T Byron would find out if this proposed diverted footpath still exist.

61. <u>PUBLIC CONSULTATION LAUNCHED FOR FORMER CRONTON COLLIERY SITE – TRITAX SYMMETRY AND THE LAND TRUST</u>

The first public consultation had been launched by Tritax Symmetry and the Land Trust on the proposed development at the former Cronton Colliery Site

The proposal was briefly considered and the followings were highlighted:

- Traffic and speed limit on Cronton Road.
- Potential security/anti-social behaviour issues relating to the proposed country park and cycle path.
- Local Police should be made aware of the concerns.

Councillor R Gaffney responded that there would be a substantial highway improvement to manage traffic demand and speed limits were under review.

The proposal would be fully considered when a planning application was submitted to Knowsley Council.

62. NEW WEBSITE

63. VILLAGE AND COMMUNITY ISSUES

- (a) The 20mph speed limit sign at the junction of Smithy Lane and Cronton Road was obstructed by overgrown tree branches.
- (b) Cars partly parked on pavement further down Dandelion Tavern obstructing and causing danger to other road and footway users. Extended double yellow lines were suggested. The situation could only be attended to by the Civil Enforcement Officers within office hours.
- (b) Coronation Gardens maintenance Routine maintenance was overdue.
- (c) Remembrance Sunday Service Arrangements to be reviewed due to covid-19 restrictions.
- (d) Ecumenical Carol Service To consult both schools.
- (e) St Ann's Well maintenance and floral display for Cronton Thank you letters to Mr Ken Bevan and Steve Doyle (Cronton Garden Centre).
